From Manners to Rules

The revised Health Promotion Act was fully implemented from April 1, 2020.

Smoking is not allowed in many buildings.

People under 20 years old are not allowed in the smoking rooms.

Setting an indoor smoking room is required.

Obligated to indicate the smoking room.
(Posting stickers)



To All the Business Operators

No smoking indoors is the general rule.

Hospitals and Schools

Schools, child welfare buildings, hospitals, clinics, government buildings, etc.

Restaurants

Offices, working places, etc.

Offices, factories, hotels, inns, ships and railways used for transport service, and all other facilities

Smoking is not allowed in facilities from July 1, 2019.
*Implementing a smoking area outdoors is also possible.

Smoking is not allowed indoors in general from April 1, 2020.
*Implementing a smoking room or for heated tobacco products users room is also possible.

What is PayB?

PayB is a Multifunctional Payment App that allows easier payments for Municipal tax etc., through a registered bank account from anywhere, anytime, using the barcode printed on the payslip for convenience stores.

*Transmission fees shall be paid on your own expenses.



【Remarks】

- A payslip with expired due date cannot be used.
- A payslip with more than 300,000 yen payment cannot be used.
- The App is free but transmission fees shall be paid on your own expenses.
- Receipt will not be issued. Check the notification mail, transaction record or bankbook record.
- Tax payment cannot be confirmed for about 5 days after the payment is made and the tax payment certificate cannot be issued.
- Do not use PayB but make the payment at the financial institutions listed on the back of the payslip, convenience stores, city hall or branch offices when receipt or tax payment certificate for automobile inspection (continuous inspection) is required.
- Only personal savings account can be registered (unavailable for corporate account).
- Cannot be paid by credit card. Only account transfer from the designated financial institutions are available.
- Payments cannot be canceled from the app after paying with PayB. Be aware of duplicate payments by tearing the used payslips.

FY 2020 Overview of the Initial Budget

The general budget is the core budget, covering revenue and expenditures excluding special budgets.

The initial general budget for fiscal 2020 is 61,576,000,000 yen, which is about 6,824,000,000 yen more than the budget last term.

▶ Comparing the municipal budget to a family budget

The city has many sources of revenue and expenses that differ somewhat from a normal household so it doesn't line up exactly, but here is what a monthly balance book might look like if we made the city into a household with an annual income (including allowances) of 5 million yen.

Revenue

While the base income decreased, the allowances increased, and the total monthly income increased. But the part-time income decreased. Withdrawals from savings and bank loan increased with increased spending on housing constructions and repairs.



Expenses

The total increased from the previous year due to increased spending on our housing construction and repair, although support for reconstruction of the relative's house reduced.







Wages and allowances for employees

Monies for supporting people eligible for welfare or child assistance

Monies for making roads, school, parks, etc.
- **Supplies:**
Monies required for operations
- **Required expenses:**
Obligations for the city including personnel, social assistance, and servicing public debt
- **Investment expenses:**
Monies spent on buildings, roads and other facilities that will remain beyond the current fiscal period

Ride Bicycles Safely!

Riding a bicycle bears the same responsibility for obeying the traffic rules as when driving a car and violations of the rule may be subject to penalties.



- ① In general, bicycles shall be on the driveway.
- ② Ride the left side of the road.
- ③ Pedestrians shall be prioritized on the sidewalk and ride the bicycle slowly on the driveway side of the sidewalk.
- ④ Obey the safety rules.
- ⑤ Child must wear a helmet.

Bicycles can only ride on the sidewalk in specific conditions such as when the road sign indicates bicycles are allowed on the sidewalk, riders younger than 13 years old or older than 70 years old, the rider has a physical disability, the left side of the driveway is blocked due to road work.

- It is prohibited to drink and ride, double ride and ride side by side.
- Turn on the light at night.
- Make sure to obey the traffic lights, stops, and safety check at the intersections.

● Criminal liability or compensation for damage may be required when somebody is injured. Join an insurance plan considering those responsibilities.

Submit your payments promptly!

Avoid missed payments by setting up direct debit payments from your bank account. If you have already set up direct debit payments for your taxes, be sure that your account has sufficient funds available by the day before payment is due.

If you are too busy during the day on weekdays to make your payment...

A tax payment service counter will be open every Sunday. (Except year end/New Years)

- ① The main building's second floor will be open to answer tax-payment related questions.
