Eligibility

Aichi Prefectural Komaki Junior High School (evening junior high school) will open inside Komaki High School in April (1-321 Komaki, Komaki).

People who live or work in Aichi Prefecture, who are over 15 years old and meet one of the following criteria: ① or ②

- ① Persons who have not completed compulsory education in Japan or abroad
 - ② Those who graduated from junior high school without receiving adequate education due to various reasons, such as not attending school
- *People with foreign roots can also enroll.
 *Tuition and textbooks are free.

Subsidy for the mumps vaccine

People who receive vaccines at designated medical institutions in Komaki City ▶ Make an appointment at the hospital before receiving the vaccine. The vaccination is free.

People who receive vaccines at medical institutions outside of Komaki City ▶ Make an appointment at the hospital before receiving the vaccine. Pay at the hospital for the vaccine.

If you take the receipt with "mumps vaccine" written on it and your Parent and Child Health Handbook (Maternal and Child Health Handbook) and bank passbook (account information for receiving funds) to the public health center and go through the procedures, some of the money will be returned to you later. Applications for vaccines performed before March 3 must be submitted by March 31.

● Eligibility: Children from one year old until they enter elementary school (once per person)

● Other: Born April 2, 2019 to April 1, 2020 have deadline for support of March 31, 2026. Those who have never been vaccinated using Komaki City's subsidies and wish to be vaccinated should apply directly to a designated medical institution in the city for vaccination.

The 2nd Series of Regular Vaccinations for Mumps/Rubella (MR)

The deadline for vaccination for those eligible in FY2025 is March 31, 2026. Receive the vaccination earlier when you are feeling well (physically).

● Eligibility: Born between April 2, 2019 and April 1, 2020

● Other: If you do not have a pre-examination questionnaire, please contact the Health Center. Persons wishing to be vaccinated at hospitals or clinics outside Komaki City should submit paperwork at the Health Center.

Fixed Asset & City Planning Tax (4th Term)

Avoid missed payments by setting up direct debit payments from your bank account.

National Health Insurance Tax (9th term)

If you have already set up direct debit payments for your taxes, be sure that your account has sufficient funds available by the day before payment is due.

Nursing Care Insurance Fees (8th term)

You can pay taxes using smartphone apps including PayB or PayPay.

Late-Term Medical Insurance for the Elderly (7th term)

*Persons using direct deposit to account cannot use payment by app.
Instructions are available on the website of the app.



When you are unable to pay by the predetermined date due to decreased wages or other reason, consult with the taxation division.

If the deadline passes, you will need to pay arrears (penalty for late payment).

If you are too busy during the day on weekdays to make your payment...

A tax payment service counter will be open every Sunday.
(Except year end/ New Years)

① The main building's second floor will be open to answer tax-payment related questions.
Payments are accepted as well.

Hours ▶ Feb 22 (Sun) 9:00 to 12:00

② The main building's first floor will be open to pay taxes.

Hours ▶ Feb 8 (Sun), 22 (Sun) 9:00 to 16:00

③ You can pay for payment notices with bar codes at convenience stores.

Tax Declarations

This is the procedure for informing the government how much money you earned in a year or how much tax you must pay.

Persons that must file

Self-employed individuals, those with an annual income of 20 million yen or more, those with side income exceeding 200,000 yen, and those wishing to claim medical expense deductions may be required to file a tax return.

Open Days

Feb 16 (Mon) to Mar 16 (Mon), 2026

(Not open weekends and holidays. Open Mar 1 (Sun))

- ▶ Income, special recovery income and gift taxes must be declared and paid by Mar 16 (Mon). Consumption taxes and local consumptions taxes must be declared and paid by sole proprietors by Mar 31 (Tue).
- ▶ Tax declaration consultation is not held at the tax office during this period (Feb 16 (Mon) to Mar 16 (Mon)).
- Only completed declaration forms may be submitted.
- ▶ To enter the venue you will need a ticket handed out on the day.

You can get a ticket in advance using the National Tax Agency LINE account.



Open Hours


9:00 to 17:00 (Reception ends at 16:00)
