## ▼ Cancer screening

Cancer screening detects the disease before the body shows any symptoms. Why not take advantage of this opportunity? There are two types of checkups: group checkups at health centers and individual checkups at medical institutions. You can take one screening between June 2026 and February 2027 (March for breast and uterine cancer screening).

## Aid for Purchase of Medical Assistive Devices for Persons Living with Cancer

To reduce the mental and financial burden of persons living with cancer and promote their treatment, employment and participation in society, Komaki City provides financial aid for part of the expenses of purchasing medical assistive devices.

#### Eligibility

- **Epithese** ... prosthetic devices that replace the missing appearance of the face (eyes, ears), fingers, etc., due to cancer treatment] for purchases from April 1, 2026 (newly covered)
- **Wigs** (including scalp protection nets)
- **Breast prosthesis** ... prosthetic breast pad and artificial masts (including mastectomy bras)

#### Amount of support

**Half of purchase price**  
(all maximum amount of 20,000 yen)

## Aid for at-home care (service at home) for cancer patients

The City provides partial support for expenses related to home service care so that persons living with cancer can stay at home without worry.

#### Eligibility

Persons living with cancer (limited to persons determined by a physician to have progressed beyond the ability of medicine to treat) under 40 that require assistance for living at home or nursing care

#### Amount of support

**90% of the expenses of covered services**  
(up to 54,000 yen/month)

## Next tax payment deadline: **June 30 (Tue)**

**Ordinary Municipal Tax and Forest Environment Tax (1st term)**

**National Health Insurance tax (1st term)**

**Submit your payments promptly!**

Avoid missed payments by setting up direct debit payments from your bank account. If you have already set up direct debit payments for your taxes, be sure that your account has sufficient funds available by the day before payment is due. You can pay taxes using smartphone apps including PayB or PayPay.

\* Persons using direct deposit to account cannot use payment by app. Instructions are available on the website of the app.



When you are unable to pay by the predetermined date due to decreased wages or other reason, consult with the taxation division. If the deadline passes, you will need to pay arrears (penalty for late payment).

If you are too busy during the day on weekdays to make your payment...

▶ You can pay at a tax payment service counter open every Sunday.  
(Except year end/New Years)



① The main building's second floor will be open to answer tax-payment related questions. Payments are accepted as well.

### How to Apply

Apply with your bank passbook, personal seal and tax invoice (notice for tax payment from City Hall) at your bank or other financial institution.  
(The account transfer form is available at banks, City Hall (Health Insurance and Healthcare Department), Shinooka Branch Office, Ajioka Branch Office, Kitazato Branch Office.)

You can perform the bank transfer procedure by cash card at City Hall.

## FY2026 National Health Insurance Premium Notifications are in the mail

A letter informing you about your National Health Insurance Premiums for 2026 will be sent at the middle of June. Premiums for people registered with National Health Insurance in Komaki from April 2026 are based on your income (such as wages received from a company) in 2025.

### Calculation for National Health Insurance Premium will change.

Calculation for National Health Insurance Premium will gradually change every year. Please come to City Hall for a consultation if you have any questions regarding calculation method.



### ▶ Tax exemptions and reductions

If you have become unable to pay the taxes for some unavoidable reason such as accident, death, chronic illness, or major loss of income such as by job loss, and if you apply by the deadline, taxes may be reduced. Please consult with us.

### ▶ When you receive your company's qualification confirmation certificate or admission information letter.

If you have health insurance at your company, you must perform procedures to leave National Health Insurance.

Once you receive a letter from the company confirming your qualification or admission information, please contact City Hall.

## FY2026 Municipal and Prefectural Tax Payment Notices are being issued

### ▶ Municipal and Prefectural Tax Payment Notices are in the mail

FY2026 Tax Payment Notices will be sent in early June.

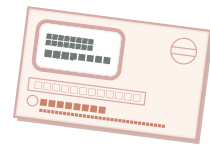
Individual municipal and prefectural taxes are collected against the income of the previous year for all persons with an address in the city as of January 1, 2026. If you were not in Japan on January 1, but return to Japan within a year, you may be subject to taxation.

Taxes are based on your income (such as wages received from a company) in 2025.

### ▶ Exemptions and reductions

You may be able to reduce\* the amount of taxes required when you have difficulties to pay taxes due to severe reduction of income because of resignation\*, disaster, death or extended treatment or disease.

The application deadline is the later date of either 30 days later, counted from the date of resignation, death, etc., or the payment deadline.



## Application Counter for FY2026 Income (Taxable) Certificate etc.

From Jun 1 (Mon) you can obtain a 2026 income (taxation) certificate, etc. (300 yen per copy).

If you want a certificate of residence, etc., you can get both at the Residents Service Counter on the first floor of the Main Building of City Hall.

The Taxation Division of City Hall from Jun 1 (Mon) will change the place to obtain income (taxation) certificates and corporate citizen's tax business certificates because the counter is crowded.

(Excludes Saturday and Sunday. However, it may be received at the Citizen Inquiry Division Holiday Service Counter on second and fourth Sundays.)  
(Only persons with information about income or that apply may receive it.)

#### Venue

**Conference room 202, City Hall Main Building 2F, City Hall**

- The person who comes to the counter must bring their personal identification (Zairyu card, driver's license, individual number card, etc.)
- A letter of attorney is required if the person coming to the counter is not the applicant or their family member who live together.
- When the person has no income for the applied year or income information is not clear, a certificate can be received by submitting an application form at the Taxation Division.
- From July 1 (Wed), it can be received as normal from Service Counter 4 of the Taxation Division at 2F of the main building at City Hall.

#### Issuance at convenience stores

Service at convenience store and other locations is normally available from 6:30 to 23:00. (150 yen each) Only the Income (Taxable) Certificates for FY2026 are available.
